## Information about the Use of Mark of Distinction Recognition Incentives

Recognition incentives will be awarded at the 2017 NSPRA Seminar in San Antonio.

In addition to the specific incentives outlined above, all recognized chapters will receive certificates of award suitable for framing. Those chapters recognized as "exemplary" may use the specially designed "Mark of Distinction" on chapter websites and on printed materials and letterhead.

- \* Seminar and Pre-Seminar Workshop discounts may be used only at the time of registration (a discount incentive may not replace a 2018 Anaheim Seminar registration that has been submitted and processed. No refunds will be given). Discount incentives may not be combined with other special discounts other than those directly related to registration (i.e., Super Early-Bird and Early-Bird offers). Discount incentive awards apply only to the 2018 Anaheim Seminar and may not be deferred for use beyond that date.
- \*\* Chapters may select a PR Power Hour of their choice from the schedule of posted sessions for the 2017-2018 program year. PR Power Hour incentive awards may not be deferred for use beyond the designated year.
